  - 2 tives of the United States of America in Congress assembled,

### **3** SECTION 1. SHORT TITLE; TABLE OF CONTENTS.

4 (a) SHORT TITLE.—This Act may be cited as the

5 "National Fish Habitat Conservation Act".

### 1 SEC. 2. FINDINGS; PURPOSES.

2 (a) FINDINGS.—Congress makes the following find-3 ings:

4 (1) Healthy populations of fish and other
5 aquatic organisms depend on the conservation, pro6 tection, restoration, and enhancement of aquatic
7 habitats in the United States.

habitats, including 8 (2)Aquatic wetlands. 9 streams, rivers, lakes, estuaries, coastal and marine 10 ecosystems, and associated riparian upland habitats 11 that buffer those areas from external factors, per-12 form numerous valuable environmental functions 13 which sustain environmental, social, and cultural val-14 ues, including recycling nutrients, purifying water, 15 attenuating floods, augmenting and maintaining 16 stream flows, recharging ground water, acting as 17 primary producers in the food chain, and providing

essential and significant habitat for plants, fish and
 wildlife, and other dependent species.

3 (3) The extensive and diverse aquatic habitat 4 resources of the United States are of enormous sig-5 nificance to the economy of the United States, pro-6 viding recreation for 44,000,000 anglers, more than 7 1,000,000 jobs and approximately \$125,000,000,000 8 in economic impact each year related to recreational 9 fishing, and approximately 500,000 jobs and an ad-10 ditional \$35,000,000,000 in economic impact from 11 commercial fishing each year.

12 (4) At least 40 percent of all threatened and
13 endangered species in the United States are directly
14 dependent upon aquatic habitats.

(5) Certain fish species are considered to be ecological indicators of aquatic habitat quality, such
that the presence of such species in an aquatic ecosystem reflects high-quality habitat for other fish.

(6) Loss and degradation of aquatic habitat, riparian habitat, water quality, and water volume
caused by activities such as alteration of watercourses, stream blockages, water withdrawals and diversions, erosion, pollution, sedimentation, and destruction or modification of wetlands have caused
significant declines in fish populations throughout

the United States, especially declines in native fish
 populations, and result in economic losses to the
 United States.

4 (7) Providing for the conservation and sustain-5 ability of fish and other aquatic organisms has not 6 been fully realized despite federally funded fish and 7 wildlife restoration programs and other activities in-8 tended to conserve aquatic resources. Such conserva-9 tion and sustainability may be significantly advanced 10 through a renewed commitment and sustained, coop-11 erative efforts that are complementary to existing 12 fish and wildlife restoration programs and clean 13 water programs.

14 (8) The National Fish Habitat Action Plan pro15 vides a framework for maintaining and restoring
16 aquatic habitats to ensure perpetuation of popu17 lations of fish and other aquatic organisms.

(9) The United States can achieve significant
progress toward providing aquatic habitats for the
conservation and restoration of fish and other aquatic organisms through a voluntary, nonregulatory, incentive program that is based on technical and financial assistance provided by the Federal Government.

(10) Creation of partnerships between local citi zens, Indian tribes, Alaska Native organizations,
 corporations, nongovernmental organizations, and
 Federal, State, and Indian tribal agencies is critical
 to the success of activities to restore aquatic habi tats and ecosystems.

7 (11) The Federal Government has numerous 8 regulatory and land and water management agen-9 cies, including the United States Fish and Wildlife 10 Service, the Bureau of Land Management, the Na-11 tional Park Service, the Bureau of Reclamation, the 12 Bureau of Indian Affairs, the National Marine Fish-13 eries Service, the Forest Service, the Fishery Man-14 agement Councils, the Environmental Protection 15 Agency, and the several interjurisdictional fishery 16 commissions that are critical to the implementation 17 of the National Fish Habitat Action Plan.

18 (12) The United States Fish and Wildlife Serv-19 ice, the Forest Service, and the National Marine 20 Fisheries Service each plays a vital role in the pro-21 tection, restoration, and enhancement of the fish 22 communities and aquatic habitats in the United 23 States and the development, operation, and long-24 term success of fish habitat partnerships and project 25 implementation.

(13) The United States Geological Survey plays
 a vital role in scientific evaluation, data collection,
 and mapping for fishery resources in the United
 States.

5 (14) Many of the programs for conservation on 6 private farmland, ranchland, and forestland that are 7 carried out by the Secretary of Agriculture, includ-8 ing the Natural Resources Conservation Service and 9 the State and Private Forestry programs of the For-10 est Service, are able to significantly contribute to the 11 implementation of the National Fish Habitat Action 12 Plan through the engagement of private landowners. 13 (b) PURPOSES.—The purposes of this Act are to en-14 courage partnerships among public agencies and other in-15 terests consistent with the mission and goals of the National Fish Habitat Action Plan— 16

17 (1) to protect and maintain intact and healthy18 aquatic habitats;

19 (2) to prevent further degradation of aquatic20 habitats that have been adversely affected;

(3) to reverse declines in the quality and quantity of aquatic habitats to improve the overall health
of fish and other aquatic organisms;

1	(4) to increase the quality and quantity of
2	aquatic habitats that support a broad natural diver-
3	sity of fish and other aquatic species;
4	(5) to improve fisheries habitat, thereby improv-
5	ing the annual economic output from recreational,
6	subsistence, and commercial fishing;
7	(6) to ensure coordination and facilitation of ac-
8	tivities carried out by agencies or departments of the
9	United States under the leadership of the Director
10	of the United States Fish and Wildlife Service, the
11	Under Secretary for Oceans and Atmosphere of the
12	Department of Commerce, and the Director of the
13	United States Geological Survey; and
14	(7) to achieve other purposes in accordance
15	with the mission and goals of the National Fish
16	Habitat Action Plan.
17	SEC. 3. DEFINITIONS.
18	In this Act:
19	(1) Appropriate congressional commit-
20	TEES.—The term "appropriate congressional com-
21	mittees" means the Committee on Commerce,
22	Science, and Transportation and the Committee on
23	Environment and Public Works of the Senate and
24	the Committee on Natural Resources of the House
25	of Representatives.

1	(2) Aquatic habitat.—The term "aquatic
2	habitat''—
3	(A) means any area upon which aquatic
4	organisms depend, directly or indirectly, to
5	carry out the life processes of such organisms,
6	including an area used by such organisms for
7	spawning, incubation, nursery, rearing, growth
8	to maturity, food supply, or migration; and
9	(B) includes an area adjacent to an aquat-
10	ic environment if such adjacent area—
11	(i) contributes elements, such as the
12	input of detrital material or the promotion
13	of planktonic and insect populations pro-

- viding food, which make fish life possible;
  (ii) protects the quality and quantity
  of water sources;
- 17 (iii) provides public access for the use18 of fishery resources; or
- 19 (iv) serves as a buffer protecting the20 aquatic environment.

(3) ASSISTANT ADMINISTRATOR.—The term
"Assistant Administrator" means the Assistant Administrator for Fisheries of the National Marine
Fisheries Service.

1 (4) CONSERVATION; CONSERVE; MANAGE; MAN-2 AGEMENT.—The terms "conservation", "conserve", 3 "manage", and "management" mean to protect, sus-4 tain, and, where appropriate, restore and enhance, 5 healthy populations of fish, wildlife, and plant life, 6 as well as the habitats that are required to sustain 7 fish, wildlife, and plant life, as well as the habitats 8 that are required to sustain fish, wildlife, and plant 9 life productivity by utilizing methods and procedures 10 associated with modern scientific resource programs, 11 including protection, research, census, law enforce-12 ment, habitat management, propagation, live trapping and transplantation, and regulated taking. 13 14 (5) DIRECTOR.—Except as otherwise provided, 15 the term "Director" means the Director of the 16 United States Fish and Wildlife Service. 17 (6) FISH.—The term "fish" means any fresh-18 water, diadromous, estuarine, or marine finfish or 19 shellfish, including the egg, spawn, spat, larval, and 20 other juvenile stages of such an organism. 21 (7) FISH HABITAT CONSERVATION PARTNER-22 SHIP; PARTNERSHIP.—The terms "Fish Habitat 23 Conservation Partnership" and "Partnership" mean 24 an entity designated by the Board as a Fish Habitat

25 Conservation Partnership pursuant to section 5(a).

 (8) FISH HABITAT CONSERVATION PROJECT;
 PROJECT.—The terms "fish habitat conservation project" and "project" mean a project submitted to the Board by a Fish Habitat Conservation Partnership and approved by the Secretary under section 6 that provides for the conservation or management of aquatic habitat.
 (0) LYDIAN TERMS. The term "Indian tribe"

8 (9) INDIAN TRIBE.—The term "Indian tribe"
9 has the meaning given the term in section 4 of the
10 Indian Self-Determination and Education Assistance
11 Act (25 U.S.C. 450b).

(10) NATIONAL FISH HABITAT ACTION PLAN;
PLAN.—The terms "National Fish Habitat Action
Plan" and "Plan" mean the National Fish Habitat
Action Plan dated April 24, 2006, and any subsequent revision or amendment to that Plan.

17 (11) NATIONAL FISH HABITAT BOARD;
18 BOARD.—Except as otherwise provided, the terms
19 "National Fish Habitat Board" and "Board" mean
20 the National Fish Habitat Board established in sec21 tion 4(a).

(12) REAL PROPERTY INTEREST.—The term
"real property interest" means an ownership interest
in land or waters, including water rights, or a building or object that is permanently affixed to the land.

1	(13) SECRETARY.—The term "Secretary"
2	means the Secretary of the Interior.
3	(14) STATE AGENCY.—The term "State agen-
4	cy" means the fish and wildlife agency of a State,
5	or any department, or division of a department or
6	agency of a State that is empowered by statute or
7	by the constitution of the State to manage in the
8	public trust the inland or marine fishery resources
9	of the State.
10	SEC. 4. NATIONAL FISH HABITAT BOARD.
11	(a) Establishment.—
12	(1) IN GENERAL.—There is established a Na-
13	tional Fish Habitat Board—
14	(A) to promote, oversee, and coordinate the
15	implementation of this Act and the National
16	Fish Habitat Action Plan; and
17	(B) to review and recommend fish habitat
18	conservation projects.
19	(2) Membership.—The members of the Board
20	shall be as follows:
21	(A) The Director
22	(B) The Assistant Administrator.
23	(C) The Chief of the Natural Resources
24	Conservation Service.

1	(D) The Director of the Watershed, Fish,
2	Wildlife, Air & Rare Plants program of the For-
3	est Service.
4	(E) The Assistant Administrator for Water
5	of the Environmental Protection Agency.
6	(F) The President of the Association of
7	Fish and Wildlife Agencies.
8	(G) The Secretary of the Board of Direc-
9	tors of the National Fish and Wildlife Founda-
10	tion appointed pursuant to section $3(g)(2)(B)$
11	of the National Fish and Wildlife Foundation
12	Establishment Act (16 U.S.C. $3702(g)(2)(B)$ ).
13	(H) Four representatives of State agencies,
14	each 1 of whom is nominated by 1 of the re-
15	gions Associations of Fish and Wildlife Agen-
16	cies (Northeast, Southeast, Midwest, and West-
17	ern).
18	(I) One representative of the American
19	Fisheries Society.
20	(J) Two representatives of Indian tribes, 1
21	of whom shall represent Indian tribes from
22	Alaska and 1 of whom shall represent Indian
23	tribes from the other States.
24	(K) One member who represents the Re-
25	gional Fishery Management Councils estab-

1	lished under section 302 of the Magnuson-Ste-
2	vens Fishery Conservation and Management
3	Act (16 U.S.C. 1852).
4	(L) One member who represents the Ma-
5	rine Fisheries Commissions (the Atlantic States
6	Marine Fisheries Commission, the Gulf States
7	Marine Fisheries Commission, and the Pacific
8	States Marine Fisheries Commission).
9	(M) One representative from the
10	Sportfishing and Boating Partnership Council.
11	(N) Eleven members each of whom rep-
12	resents the interests of 1 of the following:
13	(i) The recreational sportfishing in-
14	dustry.
15	(ii) The commercial sportfishing in-
16	dustry.
17	(iii) Subsistence fishermen.
18	(iv) Marine recreational anglers.
19	(v) Freshwater recreational anglers.
20	(vi) Terrestrial resource conservation
21	organizations.
22	(vii) Aquatic resource conservation or-
23	ganizations.
24	(viii) The livestock and poultry pro-
25	duction industry.

1	(ix) The housing development indus-
2	try.
3	(x) The row crop industry.
4	(xi) Natural resource commodity in-
5	terests, such as petroleum or mineral ex-
6	traction.
7	(3) Compensation.—Members of the Board
8	shall serve without compensation for that service.
9	(b) Appointment and Terms.—
10	(1) IN GENERAL.—Except as otherwise pro-
11	vided in this subsection, a member of the Board de-
12	scribed in subparagraphs (H) through (N) of sub-
13	section $(a)(2)$ shall serve for a term of 3 years.
14	(2) INITIAL BOARD MEMBERSHIP.—Not later
15	than 6 months after the date of the enactment of
16	this Act, the representatives of the National Fish
17	Habitat Board established by the Plan shall appoint
18	the initial members of the Board described in sub-
19	paragraphs (H) through (N) of subsection $(a)(2)$ .
20	(3) TRANSITIONAL TERMS.—The initial ap-
21	pointments of the members of the Board described
22	in subparagraph (N) of subsection $(a)(2)$ shall be for
23	terms as follows:
24	(A) Four shall be appointed for a term of
25	1 year.

1	(B) Four shall be appointed for a term of
2	2 years.
3	(C) Three shall be appointed for a term of
4	3 years.
5	(4) VACANCIES.—A vacancy of a member of the
6	Board described in subparagraphs (H) through (N)
7	of subsection $(a)(2)$ shall be filled by an appointment
8	made by the remaining members of the Board.
9	(5) CONTINUATION OF SERVICE.—An individual
10	whose term of service as a member of the Board ex-
11	pires may continue to serve on the Board until a
12	successor is appointed.
13	(6) REMOVAL.—If a member of the Board de-
14	scribed in subparagraphs (H) through (N) of sub-
15	section $(a)(2)$ misses 3 consecutive regularly sched-
16	uled Board meetings, the members of the Board
17	may vote to remove that member and appoint an-
18	other individual in accordance with paragraph (4).
19	(c) CHAIR.—
20	(1) Election.—A Chair of the Board shall be
21	elected by the Board from among its members.
22	(2) TERM.—The Chair of the Board shall serve
23	for a term of 3 years.
24	(d) MEETINGS.—

1	(1) IN GENERAL.—The Board shall meet at the
2	call of the Chair but in no case less often than twice
3	a year.
4	(2) PUBLIC ACCESS.—All meetings of the
5	Board shall be open to the public.
6	(e) BOARD PROCEDURES.—
7	(1) IN GENERAL.—The Board shall establish
8	procedures to carry out the business of the Board
9	that include the following:
10	(A) A requirement that a quorum of the
11	members of the Board be present to transact
12	business.
13	(B) A requirement that no recommenda-
14	tions may be adopted by the Board, except by
15	the vote of $\frac{2}{3}$ of all members present and vot-
16	ing.
17	(C) Procedures for setting national goals
18	and priorities for aquatic habitat conservation
19	for the purposes of this Act.
20	(D) Procedures for designating Fish Habi-
21	tat Conservation Partnerships under section 5.
22	(E) Procedures for reviewing, evaluating,
23	and recommending fish habitat conservation
24	projects.

(2) QUORUM.—A majority of the members of
 the Board shall constitute a quorum.

### 3 SEC. 5. FISH HABITAT CONSERVATION PARTNERSHIPS.

4 (a) AUTHORITY TO DESIGNATE.—The Board is au5 thorized to designate Fish Habitat Conservation Partner6 ships.

7 (b) APPLICATION.—An entity seeking to be des8 ignated as a Fish Habitat Conservation Partnership shall
9 submit an application to the Board at such time and in
10 such manner as the Board may reasonably require.

11 (c) PURPOSES.—The purposes of a Partnership shall12 be—

13 (1) to coordinate implementation of the Plan at14 a regional level; and

15 (2) to develop and carry out fish habitat con-16 servation projects.

17 (d) APPROVAL.—The Board may approve an applica18 tion for a Partnership submitted under subsection (b) if
19 the Board determines that the applicant—

(1) includes representatives of a diverse group
of public and private partners, including Federal,
State, or local governments, nonprofit entities, Indian tribes, or private individuals, that are focused
on conservation of aquatic habitats to achieve results

1	across jurisdictional boundaries and public and pri-
2	vate lands;
3	(2) is organized to promote the health of impor-
4	tant aquatic habitats and distinct geographic areas,
5	keystone fish species, or system types, including res-
6	ervoirs, natural lakes, or estuaries;
7	(3) identifies strategic fish and aquatic habitat
8	priorities for the Partnership area in the form of ge-
9	ographic focus areas or key stressors or impairments
10	to facilitate strategic planning and decisionmaking;
11	(4) is able to address issues and priorities at a
12	nationally significant scale;
13	(5) includes governance structures that reflect
14	the range of all partners and promotes joint stra-
15	tegic planning and decisionmaking by the applicant;
16	(6) demonstrates completion of, or significant
17	progress toward the development of, a strategic plan
18	to address the causes of system decline in fish popu-
19	lations rather than simply treating symptoms in ac-
20	cordance with the Plan; and
21	(7) ensures collaboration in developing a stra-
22	tegic vision and implementation program that is sci-
23	entifically sound and achievable.

### 24 SEC. 6. FISH HABITAT CONSERVATION PROJECTS.

25 (a) SUBMISSION TO THE BOARD.—

1	(1) IN GENERAL.—A Partnership seeking fund-
2	ing for a fish habitat conservation project shall sub-
3	mit an application to the Board for such funding at
4	such time and in such manner as the Board may
5	reasonably require.
6	(2) PROJECT FEATURES.—A fish habitat con-
7	servation project for which an application is sub-
8	mitted under this section may include—
9	(A) the provision of technical assistance to
10	a State, Indian tribe, or local community by the
11	National Fish Habitat Partnerships Office or
12	other agency to facilitate the development of
13	strategies and priorities for the conservation of
14	aquatic habitats; or
15	(B) the obtaining of a real property inter-
16	est in land or waters, including water rights, if
17	the obtaining of such interest is subject to
18	terms and conditions that will ensure that the
19	real property will be administered for the long-
20	term conservation of such lands and waters and
21	the fish dependent thereon.
22	(b) Recommendations by the Board.—Not later
23	than July 1 of each year, the Board shall submit to the
24	Secretary a description, including estimated costs, of each
25	fish habitat conservation project that the Board rec-

1	ommends that the Secretary approve and fund under this
2	Act, in order of priority of the Board's recommendations,
3	for the following fiscal year.
4	(c) CONSIDERATIONS.—The Board shall select each
5	project to be recommended to the Secretary under sub-
6	section (b)—
7	(1) based on a recommendation of the Partner-
8	ship that is, or that will be, participating actively in
9	carrying out the project; and
10	(2) after consideration of—
11	(A) the extent to which the project fulfills
12	a purpose of this Act or a goal of the Plan;
13	(B) the extent to which the project ad-
14	dresses the national priorities set by the Board;
15	(C) the availability of sufficient non-Fed-
16	eral funds to match Federal contributions for
17	the project, as required by subsection (e);
18	(D) the extent to which the project—
19	(i) increases fishing opportunities for
20	the public;
21	(ii) will be carried out through a coop-
22	erative agreement among Federal, State,
23	and local governments, Indian tribes, and
24	private entities;

1	(iii) increases public access to land
2	and waters; and
3	(iv) advances the conservation of fish
4	and wildlife species that are listed, or are
5	candidates to be listed, as threatened spe-
6	cies and endangered species under the En-
7	dangered Species Act of 1973 (16 U.S.C.
8	1531 et seq.); and
9	(E) the substantiality of the character and
10	design of the project.
11	(d) LIMITATIONS.—
12	(1) REQUIREMENTS FOR MONITORING.—No
13	fish habitat conservation project may be rec-
14	ommended by the Board under subsection (b) or
15	provided financial assistance under this Act unless
16	the project includes a monitoring plan designed to—
17	(A) appropriately assess the results of the
18	habitat protection, restoration, or enhancement
19	activities carried out with such assistance;
20	(B) recommend appropriate changes to the
21	project if such assessment substantiates that
22	the project objectives are not being met; and
23	(C) report findings of such assessment to
24	the Board.

1	(2) Acquisition of real property inter-
2	ESTS.—
3	(A) IN GENERAL.—No fish habitat con-
4	servation project that will result in the acquisi-
5	tion by the Secretary, in whole or in part, of
6	any real property interest may be recommended
7	by the Board under subsection (b) or provided
8	financial assistance under this Act unless the
9	project meets the requirements of subparagraph
10	(B).
11	(B) REQUIREMENTS.—
12	(i) IN GENERAL.—Any real property
13	interest acquired by the Secretary pursu-
14	ant to a fish habitat conservation project
15	may not be conveyed to a State, another
16	public agency, or another entity unless—
17	(I) the Secretary determines that
18	such State, agency, or other entity is
19	obligated to undertake the manage-
20	ment of the property being conveyed
21	in accordance with the purposes of
22	this Act; and
23	(II) the deed or other instrument
24	of transfer contains provisions for the
25	reversion of title to the property to

1	the United States if such State, agen-
2	cy, or other entity fails to manage the
3	property in accordance with the pur-
4	poses of this Act.

5 (ii) Additional conveyance condi-TIONS.—Any real property interest ac-6 7 quired by the Secretary pursuant to a fish 8 habitat conservation project conveyed as 9 described in clause (i) shall be subject to 10 such terms and conditions that will ensure 11 that the interest will be administered for 12 the long-term conservation and manage-13 ment of the aquatic ecosystem and the fish 14 and wildlife dependent thereon.

(e) Non-Federal Contribution for Projects.—

16 (1) IN GENERAL.—Except as provided in para17 graph (2), no fish habitat conservation project may
18 be recommended by the Board under subsection (b)
19 or provided financial assistance under this Act un20 less at least 50 percent of the cost of the project will
21 be funded with non-Federal funds.

(2) PROJECTS ON FEDERAL LAND OR WATERS.—Notwithstanding paragraph (1), Federal
funds may be used for payment of 100 percent of
the costs of a project located on Federal land or wa-

ters, including the acquisition of inholdings within
 such land and waters.
 (3) NON-FEDERAL SHARE.—The non-Federal
 share of the cost of a project may not be derived

from a Federal grant program, but may include in-kind contributions and cash.

7 (4) SPECIAL RULE FOR ALASKA NATIVE ORGA8 NIZATIONS.—Notwithstanding paragraph (1) or any
9 other provision of law, any funds made available to
10 an Indian tribe pursuant to this Act may be consid11 ered non-Federal funds for the purpose of paragraph
12 (1).

13 (f) CONSIDERATION BY THE SECRETARY.—

14 (1) IN GENERAL.—Not later than 180 days
15 after receiving the recommendations of the Board
16 for fish habitat conservation projects under sub17 section (b), the Secretary shall approve, reject, or re18 order the priority of each such recommendation
19 based on, to the greatest extent practicable, the cri20 teria described in subsection (c).

(2) FUNDING.—If the Secretary approves a
project, the Secretary shall use amounts made available pursuant to an authorization of appropriations
in this Act to provide funds to carry out the project.

1 (3) NOTIFICATION BY THE SECRETARY.—If the 2 Secretary rejects or reorders the priority of any project recommended by the Board under subsection 3 4 (b), the Secretary shall provide to the Board and the 5 appropriate Fish Habitat Conservation Partnership 6 a written statement of the reasons that the Sec-7 retary rejected or modified the priority of the 8 project.

### 9 SEC. 7. NATIONAL FISH HABITAT CONSERVATION PART-10 NERSHIP OFFICE.

(a) REQUIREMENT TO ESTABLISH.—Not later than
1 year after the date of the enactment of this Act, the
Director shall create the National Fish Habitat Conservation Partnership Office within the United States Fish and
Wildlife Service.

16 (b) FUNCTIONS.—The National Fish Habitat Con-17 servation Partnership Office shall—

(1) provide funding for the operational needs of
the Fish Habitat Conservation Partnerships, including funding for activities such as planning, project
development and implementation, coordination, monitoring, communication, and outreach;

23 (2) facilitate the cooperative development and24 approval of Partnerships;

1	(3) support the development and implementa-
2	tion of fish habitat conservation projects that are
3	identified as high priorities by the Board;
4	(4) assist the Secretary and the Board in car-
5	rying out this Act;
6	(5) assist the Secretary in carrying out the re-
7	quirements of section 9;
8	(6) facilitate communication, cohesiveness, and
9	efficient operations for the benefit of the Partner-
10	ships and the Board;
11	(7) facilitate, with assistance from the Director,
12	the Assistant Administrator, and the President of
13	the Association of Fish and Wildlife Agencies, the
14	consideration of projects by the Board;
15	(8) provide support to the Director in the devel-
16	opment and implementation of the interagency oper-
17	ational plan required in subsection (c);
18	(9) provide technical and scientific assistance
19	pursuant to the technical and scientific assistance
20	program required by subsection (d); and
21	(10) coordinate and facilitate the resources and
22	activities of the agencies and departments of the
23	United States to carry out this Act in an efficient
24	manner.

1 (c) INTERAGENCY OPERATIONAL PLAN.—Not later 2 than 1 year after the date of the enactment of this Act and every 5 years thereafter, the Director, in cooperation 3 4 with the Assistant Administrator and the heads of other appropriate Federal agencies and departments, shall de-5 velop an interagency operational plan for the National 6 7 Fish Habitat Conservation Partnership Office that de-8 scribes-

9 (1) the functional, operational, technical, sci10 entific and general staff, administrative, and mate11 rial needs of the Office; and

12 (2) any interagency agreements between or
13 among Federal agencies or departments to address
14 such needs.

15 (d) TECHNICAL AND SCIENTIFIC ASSISTANCE.—The 16 Director, in coordination with the Assistance Adminis-17 trator and the heads of the United States Geological Sur-18 vey, the Forest Service, and other appropriate Federal 19 agencies and departments, shall develop a technical and 20 scientific assistance program within the National Fish 21 Habitat Conservation Partnership Office—

(1) to provide scientific and technical assistance
to States, Indian tribes, regions, local communities,
and nongovernmental organizations in the develop-

1	ment and implementation of Fish Habitat Conserva-
2	tion Partnerships; and
3	(2) to ensure the availability of expertise to con-
4	duct scientifically based evaluation and reporting of
5	results of fish habitat conservation projects to meet
6	the reporting requirements described in section 10.
7	(e) STAFF AND SUPPORT.—
8	(1) Departments of the interior and com-
9	MERCE.—The Director and the Assistant Adminis-
10	trator shall each provide appropriate staff to support
11	the National Fish Habitat Conservation Partnership
12	Office.
13	(2) STATES.—The States are encouraged to
14	provide staff to support the National Fish Habitat
15	Conservation Partnership Office.
16	(3) Detailees and contractors.—The Na-
17	tional Fish Habitat Conservation Partnership Office
18	may accept staff or other administrative support
19	from other entities through interagency details or as
20	contractors.
21	(4) QUALIFICATIONS.—The members of the
22	staff of the National Fish Habitat Conservation
23	Partnership Office shall have education and experi-
24	ence in the principles of fish, wildlife, and aquatic

25 habitat conservation.

(f) REPORTING.—Not less frequently than once each
 year, the Director shall provide to the Board a report on
 the activities of the National Fish Habitat Conservation
 Partnership Office.

# 5 SEC. 8. CONSERVATION OF AQUATIC HABITAT FOR FISH 6 AND OTHER AQUATIC ORGANISMS ON FED7 ERAL LAND.

8 The head of each Federal agency or department re-9 sponsible for acquiring, managing, or disposing of Federal land and waters shall, to the extent consistent with the 10 mission of such agency or department and existing statu-11 tory authorities, cooperate with the Assistant Adminis-12 13 trator and the Director to conserve the aquatic habitats for fish and other aquatic organisms within the land and 14 15 waters of each such agency.

### 16 SEC. 9. COORDINATION WITH STATES.

17 The Secretary shall notify and coordinate with the18 State agency of a State not later than 30 days prior to19 the date that any action is planned or carried out within20 the State related to the implementation of this Act.

### 21 SEC. 10. ACCOUNTABILITY AND REPORTING.

- 22 (a) IMPLEMENTATION REPORTS.—
- (1) REQUIREMENT FOR REPORTS.—Not later
  than 2 years after the date of the enactment of this
  Act, and every 2 years thereafter, the Board shall

1	submit to the appropriate congressional committees
2	a report on the implementation of this Act and of
3	the Plan.
4	(2) CONTENT.—Each report submitted under
5	paragraph (1) shall include—
6	(A) an estimate of the number of acres,
7	stream miles, or acre feet of aquatic habitat, or
8	other suitable measures of aquatic habitat, that
9	was protected, restored, or enhanced under the
10	Plan by Federal, State, or local governments,
11	Indian tribes, or other entities in the United
12	States during the previous 2-year period;
13	(B) a description of the public access to
14	aquatic habitats protected, restored, or created
15	under the Plan during such period;
16	(C) a description of the opportunities for
17	public fishing created under the Plan during
18	such period; and
19	(D) an assessment of the status of fish
20	habitat conservation projects carried out with
21	funds provided under this Act, disaggregated by
22	year, including—
23	(i) a description of the fish habitat
24	conservation projects that the Board rec-
25	ommended under section 6(b);

1	(ii) a description of each such project
2	approved by the Secretary under section
3	6(f), in order of priority of receiving such
4	funding;
5	(iii) a justification for the approval of
6	each such project and for the order of pri-
7	ority for its funding;
8	(iv) a justification for any rejection or
9	reordering of the priority of each such
10	project recommended by the Board under
11	section 6(b) that was based on factors
12	other than the criteria set out in section
13	6(c); and
14	(v) an accounting of expenditures by
15	Federal, State, or local governments, In-
16	dian tribes, or other entities in the United
17	States to carry out such projects.
18	(b) STATUS AND TRENDS REPORT.—Not later than
19	December 31, 2010, and every 5 years thereafter, the
20	Board shall submit to the appropriate congressional com-
21	mittees a report on the status of aquatic habitats in the
22	United States.
23	(c) REVISIONS TO THE PLAN.—Not later than De-
24	cember 31, 2011, and every 5 years thereafter, the Board
25	shall undertake to revise the goals and other elements of

the Plan after consideration of each report required by
 subsection (b).

### 3 SEC. 11. REGULATIONS.

4 The Secretary may promulgate regulations to carry5 out this Act.

### 6 SEC. 12. CONSTRUCTION.

7 (a) WATER RIGHTS.—

8 (1) IN GENERAL.—Nothing in this Act may be9 construed—

10 (A) to create a reserved water right, ex11 pressed or implied, in the United States for any
12 purpose or to affect any water right in existence
13 on the date of the enactment of this Act; or

14 (B) to affect any Federal or State law in
15 existence on the date of the enactment of the
16 Act regarding water quality or water quantity.
17 (2) AUTHORITY TO ACQUIRE WATER RIGHTS.—
18 The Secretary may acquire, under State law, water
19 rights that are needed to carry out this Act.

20 (b) STATE AUTHORITY.—Nothing in this Act may be21 construed—

(1) to affect the authority, jurisdiction, or responsibility of a State to manage, control, or regulate fish and wildlife under the laws and regulations
of the State; or

(2) to authorize the Secretary to control or reg ulate within a State the fishing or hunting of fish
 and wildlife within the State.

4 (c) CONSTRUCTION WITH RESPECT TO RIGHTS OF
5 INDIAN TRIBES.—Nothing in this Act may be construed
6 to abrogate, abridge, affect, modify, supersede, or alter
7 any treaty-reserved right or other right of an Indian tribe
8 as recognized by any other means, including agreements
9 with the United States, Federal law, Executive orders,
10 statutes, and judicial decrees.

(d) CONSTRUCTION WITH RESPECT TO SUITS FOR
ADJUDICATION OF WATER RIGHTS.—Nothing in this Act
diminishes or affects the ability of the Secretary to join
an adjudication of rights to the use of water pursuant to
subsections (a), (b), and (c) of section 208 of the Department of Justice Appropriation Act (43 U.S.C. 666).

17 (e) CONSTRUCTION WITH RESPECT TO OTHER AU-18 THORITIES.—

(1) ACQUISITION OF LANDS AND WATERS.—
Nothing in this Act may be construed to alter or
otherwise affect the authorities, responsibilities, obligations, or powers of the Secretary to acquire land
or waters or interests therein under any other provision of law.

1 (2) PRIVATE PROPERTY PROTECTION.—Nothing 2 in this Act may be construed to permit funds made 3 available to carry out this Act to be used to acquire 4 any real property or any interest in any real prop-5 erty without the written consent of each owner of 6 that property or interest in property.

(3) MITIGATION.—Nothing in this Act may be 7 8 construed to permit funds made available to carry 9 out this Act to be used for fish and wildlife mitiga-10 tion purposes under the Federal Water Pollution 11 Control Act (33 U.S.C. 1251 et seq.), the Fish and 12 Wildlife Coordination Act (16 U.S.C. 661 et seq.), or the Water Resources Development Act of 1986 13 14 (Public Law 99–662; 100 Stat. 4082).

15 SEC. 13. APPLICABILITY OF FEDERAL ADVISORY COM16 MITTEE ACT.

Any action taken to coordinate the carrying out of
this Act with the personnel of a State agency shall not
be subject to the Federal Advisory Committee Act (5
U.S.C. App).

### 21 SEC. 14. FUNDING.

22 (a) AUTHORIZATION OF APPROPRIATIONS.—

(1) FISH HABITAT CONSERVATION PROJECTS.—
There are authorized to be appropriated to the Secretary for each of the fiscal years 2009 through

2013, \$75,000,000 to provide funds for fish habitat
 conservation projects approved under section 6(f), of
 which 5 percent shall be made available each fiscal
 year for projects carried out by Indian tribes.

5 (2) NATIONAL FISH HABITAT CONSERVATION 6 PARTNERSHIP OFFICE.—There are authorized to be 7 appropriated to the Secretary for each of the fiscal 8 years 2009 through 2013, \$3,000,000 or 25 percent 9 of the amount appropriated for such fiscal year pur-10 suant to paragraph (1), whichever is greater, for the 11 National Fish Habitat Conservation Partnership Of-12 fice.

13 (3) Planning, reporting, and administra-14 TIVE EXPENSES.—There are authorized to be appro-15 priated to the Secretary for each of the fiscal years 16 2009 through 2013, \$300,000 or 4 percent of the 17 amount appropriated for such year under paragraph 18 (1), whichever is greater, for the Board, the Direc-19 tor, and the Assistant Administrator to utilize for 20 planning and administrative expenses, and to carry 21 out section 10.

(4) AVAILABILITY OF FUNDS.—Funds made
available under this subsection shall remain available
until expended.

1 (b) AGREEMENTS AND GRANTS.—The Secretary 2 may—

3 (1) upon the recommendation of the Board, and 4 notwithstanding sections 6304 and 6305 of title 31, 5 United States Code, and the Federal Financial As-6 sistance Management Improvement Act of 1999 7 (Public Law 106–107; 31 U.S.C. 6101 note), enter 8 into a cooperative agreement or contract with a Fish 9 Habitat Conservation Partnership for fish habitat 10 conservation, restoration, and enhancement projects; 11 (2) apply for, accept, and use grants from any 12 person or entity to carry out the purposes of this 13 Act: and

(3) make funds available to any Federal agency
or department for use by that agency or department
to award grants for any fish habitat protection, restoration, and enhancement project that the Secretary determines to be consistent with this Act.

19 (c) DONATIONS.—

20 (1) IN GENERAL.—The Secretary may—

21 (A) enter into an agreement with any orga22 nization described in section 501(c)(3) of the
23 Internal Revenue Code of 1986 and exempt
24 from taxation under section 501(a) of such

1	Code to solicit private donations to carry out
2	the purposes and policies of this Act; and
3	(B) accept donations of funds, property,
4	and services for use in carrying out the pur-
5	poses and policies of this Act.
6	(2) TREATMENT OF DONATIONS.—Donations
7	accepted under this section shall be considered as
8	gifts or bequests to, or for the use of, the United
9	States and may be used directly by the Secretary or
10	provided to other Federal agencies or departments
11	through interagency agreements.
